The Syndicate at its 704th meeting held on 29/10//2022, vide agenda item read as paper (1) above considered the proposal for Hostel fee revision and fee unification along with the recommendations of the standing committees of the Syndicate on Finance and Purchase and Academic matters and resolved to increase the Hostel Fee by 5% of the existing fee of each Hostel.

The Syndicate, also resolved to increase the fine on defaulters (beyond 20 days) of Hostel fee from Rs.2/- per day to Rs.4/- per day and make this applicable in the case of guests also (in addition to the lumpsum fine) prescribed in Hostel rules read as paper(3) above.

Orders are therefore issued communicating the resolution of the Syndicate effecting the revision in the Hostel fee as given below, with effect from 01-01-2023.
